Organization/Business Membership - \$125 minimum

- Voting rights of one (1) vote per membership are reserved for:
  1. All organizations/businesses on all lakes within the township of Watersmeet, MI or on Watersmeet Township boundary lakes
  2. All other organizations/businesses within Watersmeet Township
  3. All organizations/businesses whose proprietor are a property owner in Watersmeet Township or owns land abutting water on any Watersmeet Township boundary lake.
